1. **Eligibility Criteria**

The bidder must meet the following minimum technical requirements:

- The Bidder/Supplier shall have turnover, in each of the last three years (2022-23, 2023-24 and 2024-25), not less than Rs. 10 crores supported by CA certified documents
- The bidder must be OEM/ Authorized Dealer of continuous ice cream freezers.
- Must have minimum 5 years' experience in supplying, installing, and commissioning continuous ice cream freezers in India.
- The bidder/OEM must have supplied at least 5 units of 800 LPH or higher capacity continuous ice cream freezers in the last 5 years.

2. **Purchase of Bidding Document**

2.1 The bid document may be purchased by interested bidders on submission of a written application (through E-mail yogendra.sodha@amul.coop, bhargav.kanabar@amul.coop), registration on our purchase portal (<http://afdpurchase.amul.in/>) and payment of non-refundable price of the bid document (Rs. 5000- (Inclusive of GST)) through RTGS/NEFT/Fund Transfer to AmulFed Dairy, A Unit of Gujarat Co-operative Milk Marketing Federation (Bank

details are as mentioned below) on all working days (Monday to Saturday, except public holiday).

3. Submission of Bid

3.1 The bidders who purchase the bidding document are eligible for submission of bids in their name only.

4. Bid Security

4.1 All bids must be accompanied by bid security (Earnest Money Deposit – EMD) in the form specified in the bidding document. The bids not accompanied by EMD shall be summarily **REJECTED**. The bid security shall be denominated in Indian Rupees of value as specified and shall be in the form of Bank Guarantee from Nationalized or Scheduled Banks or Through RTGS/Fund Transfer (Bank detail is as below for your reference).

4.2 The Bid security may be forfeited if

- A bidder or supplier withdraws its bid during the period of bid validity specified by the bidder/ supplier on the bid form or
- In case of successful bidder/ supplier if the bidder/ supplier fails to sign the contract.

5.5 Interested bidders must submit their technical specification/detail first, only after technical evaluation/approval, bidders will be invited for submission of commercial bid.

5.6 The submitted commercial bid will open on the mentioned due date and time in the presence of the bidder's representative/ Online video conference meeting

6.1 This is a two-stage bid

6.2 All the bidders shall submit the bids through an online platform

6.2.1 Phase-I - Technical bid: Should be submitted as per the described date and time and

6.2.2 Phase- II- Only technical qualified/Successful Bidders invited to submit their commercial bid through online portal.

6.3 The technical bid shall contain all the details except the price.

6.4 Deviation sheet needs to be submitted separately and with justification of offered item/feature
