- 1.3 Vendor shall have valid FSSAI license.

#### 3. Submission of Bid

3.1 The bidders who purchase the bidding document are eligible for submission of bids in their name only.

### 4. Bid Security

- 4.1 All bids must be accompanied by bid security (Earnest Money Deposit EMD) in the form specified in the bidding document. The bids not accompanied by EMD shall be summarily <u>REJECTED</u>. The bid security shall be denominated in Indian Rupees of value as specified and shall be in the form of Bank Guarantee from Nationalized or Scheduled Banks or Through RTGS/Fund Transfer (Bank detail is as below for your reference).
- 4.2 The Bid security may be forfeited if
- ➤ A bidder or supplier withdraw its bid during the period of bid validity specified by the bidder/ supplier on the bid form or
- ➤ In case of successful bidder/ supplier if the bidder/ supplier fails to sign the contract.
