3.1 The bidders who purchase the bidding document are eligible for submission of bids in their name only.

4. Bid Security

- 4.1 All bids must be accompanied by bid security (Earnest Money Deposit EMD) in the form specified in the bidding document. The bids not accompanied by EMD shall be summarily <u>REJECTED</u>. The bid security shall be denominated in Indian Rupees of value as specified and shall be in the form of Bank Guarantee from Nationalized or Scheduled Banks or Through RTGS/Fund Transfer (Bank detail is as below for your reference).

- 5.6 The submitted commercial bid will open on the mentioned due date and time in the presence of the bidder's representative/ Online video conference meeting
