1. Eligibility Criteria

1.1 Financial Turnover:

The bidder (or supplier) must have achieved a minimum turnover of **₹50.0 crore** in each of the last three financial years (FY 21-22, FY 22-23, FY 23-24).

1.2 Experience in Similar Projects:

The bidder must have successfully completed similar projects in the last three financial years, including at least one installation with a basic project value of ₹10 crore or more.

3. Submission of Bid

- 3.1 The bidders who purchase the bidding document are eligible for submission of bids in their name only.

4. Bid Security

- 4.1 All bids must be accompanied by bid security (Earnest Money Deposit – EMD) in the form specified in the bidding document. The bids not accompanied by EMD shall be summarily **REJECTED**. The bid security shall be denominated in Indian Rupees of value as specified and shall be in the form of Bank Guarantee from Nationalized or Scheduled Banks or Through RTGS/Fund Transfer (Bank detail is as below for your reference).

- 4.2 The Bid security may be forfeited if

- A bidder or supplier withdraw its bid during the period of bid validity specified by the bidder/ supplier on the bid form or
- In case of successful bidder/ supplier if the bidder/ supplier fails to sign the contract.

- 5.4 Offer through mail/hardcopy are not accepted and stand for rejection, your competitive bids should be submitted through our online portal only.
- 5.5 Interested bidders must submit their technical specification/detail first, only after technical evaluation/approval, bidders will be invited for submission of commercial bid.
- 5.6 The submitted commercial bid will open on the mentioned due date and time in the presence of the bidder's representative/ Online video conference meeting

6. Submission & Opening of Bids

- 6.1 This is a two-stage bid
- 6.2 All the bidders shall submit the bids through an online platform
- 6.2.1 Phase-I - Technical bid: Should be submitted as per the described date and time and
- 6.2.2 Phase- II- Only technical qualified/Successful Bidders invited to submit their commercial bid through online portal.
- 6.3 The technical bid shall contain all the details except the price.

6.4 Deviation sheet needs to be submitted separately and with justification of offered item/feature
